Quarter Project #2: Independent Argument Analysis

Mr. Eble, AP Language & Composition

For this quarter project, you'll familiarize yourself with the content, arguments, and style of a syndicated columnist in Western media.

- 1. You must collect 5 articles/columns by the same author. Please provide a link on your blog post to the article.
 - For each article, spend a paragraph or so providing exigency, I.E. What is the context of the rhetoric?
 - Then, identify the author's thesis or main argument. This may be explicit or implicit.
 - Next, find the key proof for this argument in the article. Find two examples not exceeding four lines each. Explain what kind of proof / evidence the author provides. Explain why this evidence effectively supports the assertion and what strategies the author uses.
 - Analyze the author's style. Which mode(s) does the author use? What techniques make the work unique? How does the author convey his or her attitude? How does the author develop tone?
 - Finally, go to battle; show whether you agree, disagree, or would qualify the view. Support your own argument with evidence from the text and any other documented source (using an outside source is optional).
- 2. You'll also complete a Toulmin Method Analysis of **one** of the articles (see pages 125-131 of *The Language of Composition* and <u>The University of Richmond's Writing Center website for more details</u>)
- 3. Then, you'll complete an overall style analysis for your author, writing a blog post in which you note trends in the author's style / voice. You should provide specific references to lines in the text, noting
 - Your author's use of schemes & tropes
 - An explanation of your author's **voice**, with examples
 - Any comparisons (or stark contrasts) with your own writing or another prominent writer's
- 4. Finally, you'll create a 10-question AP Language & Composition Multiple Choice Quiz (over at least one of the readings) using the question stems on page three.
